Called to order 6:10

Jak Massey, Head Registrar

- Registration is officially closed. 740 players, 135 coaches.
- The coaches meeting is this Thursday, 5:30 for U6-9 and 6:30 for U10 and up. Reviewed the agenda for the meeting. There are 3 new registrars starting in the fall. This should be mentioned at the coaches meeting to prepare them.
- Discussed Korrio vs. Bonzi. Korrio doesn't support tournaments so another system would still need to be used. Tony made a motion to postpone any decisions regarding Korrio until a cost analysis and more information about the system is received. Cathy seconded, all in favor, motion passed.
- Discussed options to address the drop in numbers for U11 and up. Possibilities include co-ed teams, combining age groups and travel to Vancouver. We will survey parents to gather opinions.

Bob McIntyre, Coach – Attending on behalf of a parent of 2 former players. The players registered late and the team roster has one space left. They've played on his team for several seasons. The options are for the players to play together on another team or one to play for Bob and the other on another team.

Seth Cockrill, President

- There has been a refund requested by a coach for his 2 children because he is no longer able to coach. Tony made a motion to grant a refund minus credit card fees. Pam seconded, all in favor, Seth abstained, motion passed.

Tony Werner, Vice President

- The CKC is adding a U10 bracket for \$400/team. U11 and above will be \$450.

Cathy Reynolds, Treasurer

- Reviewed February financials. Tony made a motion to approve, Fabio seconded, all in favor, motion passed.
- Received \$4000 for heads in beds from CKC. Total for CKC is \$19,486.

Marv Kasemeier, Concessions

- Would like to sell raffle tickets for an event. Need to submit request in writing.
- A food cart will be stationed in the middle of the fields.

- Looking into getting an espresso machine.

Fabio Aloe, Field Maintenance

- The PCU camps are set for the summer, June 24-27, July 22-25 (teams) and Aug 19-22. It was discussed the LSC has not received any fees for field in 2012. The executive board will check in with Jeff Enquist about this year.
- Received grant approval for field 9 irrigation. No funds approved for painting, cleaning, and bleacher pads.
- Meeting with LCC to see if they might be interested in contributing anything to the turf field project.
- Getting a quote from Pro-Line to move sprinklers.
