Seth Cockrill, President

- Emails have gone out about not using the fields. The only one with approval now is LCC for running, not practice.
- Discussed the need for better field management. Possibly a Field Manager that directs the Field Maintenance worker.
- Having a difficult time finding a regular paint supplier.
- Clubhouse is being painted two-tone blue with grey/blue on doors and trim. Breezeway will be lighter color. Will be done by CKC. This was voted on and approved via email by the Executive Board in June. The lowest bid was accepted by Kinder Painting. Tony will work on signs to go above the doors; concessions, clubhouse, equipment room.
- Need a new updated sign for the front with our new logo. Cathy made a motion for Tony to make a new sign with a budget of \$600, Jak seconded, all in favor, motion approved. Tony will give a quote and work on getting in touch with the Blondin family.
- Received an email from Thad Scutter regarding Jose Valencia. WYSA is looking into the matter. Our decision to no longer allow him to coach stands.

Jennifer Cockrill, Secretary

Cathy Reynolds, Treasurer

- Presented May and June financials. Jenn made a motion to approve May and June financials, Jak seconded, all in favor, motion approved.
- Cathy made a motion to reimburse new referees the \$50 fee after they've worked 5 games for Longview Rec in Longview, Jenn seconded, all approved, motion approved. Tony will track the refs that fulfill the requirement.
- 501c3 status is almost complete. Need to get updated bylaws to submit with application.

Tony Werner, Coach Liaison

- 20 new refs attended clinic. One adult from Castle Rock.
- AED machine training done, it will be located in the equipment room.
- CYSA AGM is July 22nd at 6:00. Entire board has been requested to be present.
- Will coordinate with coaches for field set up for fall season.

- Recommended only doing first half of the season schedule to start with. At that time assess standings and set up the second half of the season based on levels.

Nikki Bosell, Field Monitor

- Presented the WYSA Code of Ethics. Will work with Tony Werner outside of meeting to present a plan to the board for distributions to coaches by August board meeting.

Jak Massey, Head Registrar

- Coaches meeting 5:30 for younger, 6:30 for older, Aug 15.
- As of today 75 coaches, 359 players registered. No coaches for GU15, BU13, 14, 15.
- No U12 and up registrar. Jak has taken it on until a new registrar can be identified.
- Training is going well with new registrars.
- Need signed concussion form for anyone coming to walk-in, not just a check box in Bonzi.
- RMAs after July 15 will be more difficult. Registrars will need to call in information to the state. Encouraging coaches to do it right away.
- Chairs are reupholstered.
